Gaiters made in black woven fabric with an exterior grey coating dots (9921). PPE is available from size S (7) to XXXL(12).

Armguard made in black woven fabric with an exterior grey coating dots.(AG9X). PPE is available from size S (7) to XXL(11).

Armguard made in black woven fabric with an exterior grey coating dots.(AG10009V). PPE is available from size XS (6) to XXL(11).
